



## **N2NCU ONLINE TERMS OF USE**

N2N Ministries, PO Box 530044 Harlingen, Texas 78553 (referred to in this policy as “we,” “us,” or “our”) is the parent company of Nation-2-Nation Christian University (N2NCU) and the provider of the N2NCU Online website ([online.n2ncu.org](http://online.n2ncu.org)). Nation-2-Nation Christian University is a division of N2N Ministries. N2N Ministries is a registered 501(c)(3) not for profit corporation.

Degree program(s) of study offered by Nation-2-Nation Christian University have been declared exempt from the requirements for licensure under provisions of “Religious Exemption” found in Texas Education Code, Section 132.002(a)(2) as regulated by the Texas Workforce Commission. Exemption from licensure is not based upon any assessment of program quality under established licensing standards. All degrees offered by Nation-2-Nation Christian University are of an ecclesiastical nature, and whether granted or conferred, are in the restricted area of religion with the special purpose of preparing persons to work in the area of religion, whether educational or ministerial; they are not designed to be used in general academic circles.

Access to N2NCU Online is provided through a month to month \*subscription service (from now on, your "Membership") and will continue until terminated. To maintain your subscription, you must have internet service and provide us, with one or more valid payment methods.

A "Payment Method" is defined as a current, valid, accepted method of payment, which may be updated from time to time, and which will be used to make payments to your account through our third-party payment processor (i.e., PayPal). You must cancel your Membership before it renews each month to avoid billing of the next month's membership fees to your Payment Method.

N2NCU Online, its parent organization N2N Ministries, nor any other affiliate thereof, does not collect or store the financial information of its students, clients, partners or any individual. ### **FREE TRIAL**

Your N2NCU Online Membership may begin with a free trial. The free trial period will last for seven (7) days or as otherwise specified during registration and is intended to allow new members to have a unique educational experience without risk.

Unless otherwise stated at the time of purchase, free trials will automatically convert into paid subscriptions at the end of the trial period. To avoid being charged, you must cancel your subscription prior to the expiration of the trial period.

N2N Ministries determines free trial eligibility at its sole discretion. N2N Ministries may limit eligibility and duration to prevent abuse. We reserve the right to revoke the free trial and put your account on hold if we determine that you are not eligible.

### **BILLING AND CANCELLATION**

**Billing Cycle** - Your N2NCU Online Membership fee and any other charges you may incur in connection with your use of the service, will be charged on a monthly basis to your Payment Method on the calendar day corresponding to the commencement of the paying portion of your membership until your membership is canceled. Membership fees are fully earned by N2N Ministries upon payment. In some cases, your payment date may change, for example, if your Payment Method has not successfully settled or if your paid membership began on a day not contained in a given month. Visit the "My Profile" page of your N2NCU account and click on "Billing Details" to determine your present billing cycle.

**Suspension** - You may at any time and for any reason suspend billing for up to 90 days. Billing will automatically begin again after the 90-day period. Suspending billing may change your payment date. View the "Billing Details" on your profile page to determine your present billing cycle. During suspension, you will still have access to the online university, but your courses will be inaccessible. Return to "My Profile" to reactivate billing and unlock your courses. Suspending billing will NOT affect your academic progress. Upon reactivating billing, you may resume your courses from where you left off.

**Cancellation** - You may cancel your subscription with N2NCU Online at any time. Upon canceling your subscription, you will no longer have access to your courses on N2NCU Online. Course progress will be retained on accounts with canceled subscriptions for at least two years. If you wish to resume your studies, you must log into your account and set up a new subscription. Accounts with canceled subscriptions which remain continuously inactive for two or more years may be terminated, although any academic records will be retained by us, under the account holder's legal name.

There are two ways to manage your billing:

1. Access the "manage billing" portion of your profile page.

2. Manage billing from your PayPal account.

### **User responsibility**

You are responsible for ending billing at the completion of your educational goals, such as, but not limited to, the completion of the associate or bachelor's degree program, by canceling your subscription in a timely manner.
